Confirmation Statement

General Indemnity Scheme (GIS)

The GIS only extends to cover the negligence of the Community and Comprehensive Schools its servants and/or agents, and does not extend to indemnify the negligence of any third party, its servants and/or agents, by reference to Statute or at Common Law.

LIMIT OF INDEMNITY

Unlimited in amount.

TERRITORIAL LIMITS

There are no territorial limits in respect of the GIS.

JURISDICTION LIMITS

There are no jurisdiction clauses set out by the GIS. Jurisdictions are in accordance with the Jurisdiction of Courts and Enforcements of Judgments Acts of the Republic of Ireland.

DURATION OF COVER

Indefinite - Subject to change only in legislation.

INDEMNITY TO PRINCIPAL

State indemnity provides an indemnity to principal where a Community & Comprehensive School enters into a contract/agreement with a principal. The principal is indemnified for any personal injury or third party property damage losses which the principal becomes liable to pay as a result of a claim made against the principal by any person or entity which results directly from an act, error or omission of the DSA its servants and/or agents save to the extent the principal contributed to and/or caused the negligent act.

EXCLUSIONS

The following classes of claim are expressly excluded from the SCA's remit under the enacting legislation:

- claims involving a question as to the validity of any law having regard to the provisions of the Constitution;
- claims made in respect of infection, directly or indirectly, with Hepatitis C or the human immunodeficiency virus (HIV), or both, through the administration of blood or blood products or in respect of related matters;
- claims in which certain torts other than negligence are pleaded.
